THE CHALLENGE

Onnera came from a document security environment based on access to tools such as OneDrive and Office 365, where they stored all their files. They were clear that they wanted to increase security, but above all, to be in control.

In addition to wanting to better comply with the GDPR by protecting personal data, the objective was to keep critical product information safe even if it was extracted from the file server or sent to third parties. For the company, it was essential that the solution did not generate obstacles for the user, all while granting advanced controls.

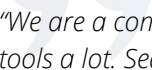
The IT team needed a simple tool to manage that would facilitate effective control, since the departments themselves had to be able to know what information they handle and to whom they must share it. In short, they were looking for a solution that would adapt to their organization without difficulty and that was simple to both apply and manage.



THE SOLUTION
